2. Grants Update, Quarterly updates completed.

Useful take aways from our visit to Washington (From last month's meeting)

- **a.** To pay for the following I will be submitting a grant application to OTS, (office of traffic safety) I believe these safety enhancements fit in well with their fundable programs.
- **b.** Other than the new firehouse information purpose of the trip the following are some good ideas we should implement.



- i. 911 phone outside of station #1. Would connect to the non-emergency sheriff's office dispatch phone. Housed in an exterior box, Cost approx.. \$300
- ii. A large 3' by 4' sign outlining the evacuation procedure. Should be located in at least 3 spots for visability. Can cost between \$500 and \$1000 each depanding on material and color
 - 1. Siren operation
 - 2. Evacuation routes
 - 3. Caution statements

4. Bulletin Board on the outside wall of Station #1

- a. 7302 will supply the funding.
- b. I am sending up a few trial balloons to gage the repercussions from the county.

5. Type 3 search

a. Pioneer Fire Protection District, (south of Placerville) is selling a 2005 HME 4x4 Wild land engine They are asking \$50,000 Could be considered as a TYPE 2 Urban Interface

PRO'S CON'S

4x4 Slightly larger than a typical TYPE 3

6-man cab Slightly heavier than a typical TYPE 3

1250 GPM 600 gal tank, SS Not as rugged

Pump and Roll Not for the average operator.
