4. Yuba Chiefs Meeting, Steve and I attended.

- a. In attendance, North San Juan, Camptonville, Pike Allegany, Downieville, and fire officers from the Forest Service.
- b. Important takeaways, 331 and 332 will be staffed 7 days a week. New air asset. Burn and campfire permits are available online. Large burn piles need to be inspected by the FS (transfer stations)

5. Communication

- a. Ruby Bluff The repeater on Ruby Bluff is a concern, John from Banner Communication with the support of the Nevada County Sherriff returned to the site and found the snow had melted below the PG&E meter where there was a disconnected conduit that allowed water into the breaker box. When snow depth allows PG&E will need to make repairs
- **b.** Still under consideration to make the comms in town optimal is for a repeater in town located high up on Sunnyside, Patty Jeans or Garretts
 - i. Estimated cost \$3,000 installation and programing all radios.
 - ii. This will optimize the functionality of the intown pagers and radios even during storms and power outages.
 - iii. Problem will be the use of another frequency requiring training on when and how

6. Sierra County Department of OES

- **c.** Should be a benefit to the department with the more transparent distribution and accounting of emergency funding.
